Terms & Conditions

1. Introduction

These Terms & Conditions ("Terms") govern participation in all camps, treks, expeditions, educational tours, adventure activities, training programs, corporate events, and other services organized by **Gemini Adventure Camp Pvt. Ltd.**

By registering, booking, making payment, or participating in any activity organized by Gemini Adventure Camp Pvt. Ltd., participants, parents, guardians, schools, colleges, organizations, and corporate groups agree to comply with these Terms & Conditions.

2. Eligibility

- Participants must provide accurate and complete registration information.
 - Minors (below 18 years) must obtain consent from a parent, guardian, school, or authorized representative.
 - Participants must be physically and mentally fit to participate in the selected activity.
 - Gemini Adventure Camp reserves the right to refuse participation if a participant is deemed medically unfit or poses a safety risk.

3. Registration & Booking

- Bookings shall be confirmed only after receipt of the prescribed registration form and applicable payment.
 - Limited seats are available for most programs and shall be allotted on a first-come, first-served basis.
 - Participants are responsible for ensuring the accuracy of all information submitted during registration.

4. Payment Terms

- Full or partial payment may be required at the time of booking.
 - All payments must be made through approved payment methods.
 - Any outstanding balance must be cleared before the commencement of the activity.
 - Failure to make timely payment may result in cancellation of the booking.

5. Cancellation & Refund Policy

Cancellation by Participant

- 10–15 days before departure: Up to 75% refund may be provided.
- 7–10 days before departure: Up to 50% refund may be provided.
- Less than 6 days before departure: No refund unless specifically approved by management.
- No refund shall be provided for:
 - No-shows
 - Late arrivals
 - Voluntary withdrawal during the program
 - Unused services

Cancellation by Company

Gemini Adventure Camp reserves the right to cancel, postpone, modify, or reschedule any activity due to:

- Weather conditions
- Natural disasters
- Government restrictions
- Safety concerns
- Insufficient registrations
- Force majeure events

In such cases, participants may be offered:

- Rescheduling,
 - Credit for future activities, or
 - Refund as determined by the Company.

6. Assumption of Risk

Adventure activities inherently involve certain risks, including but not limited to:

- Slips, falls, and injuries
- Wildlife encounters
- Weather-related hazards
- Transportation risks
- Physical exertion

Participants voluntarily assume all risks associated with participation and acknowledge that no adventure activity can be completely risk-free.

7. Medical Fitness

Participants must:

- Disclose any medical condition, allergy, injury, disability, or medication requirement.
- Carry personal medications if necessary.
- Inform organizers immediately in case of illness or injury.

Gemini Adventure Camp may deny participation if a medical condition poses a safety concern.

8. Emergency Medical Treatment

In case of emergency:

- The Company may arrange first aid, medical assistance, hospitalization, evacuation, or transportation as deemed necessary.
 - Any medical, hospitalization, evacuation, or related expenses shall be borne by the participant or guardian unless otherwise covered by insurance.

9. Safety Compliance

Participants must:

- Follow all safety instructions provided by guides, trainers, instructors, and camp leaders.
- Use safety equipment properly.
- Respect local laws and regulations.
- Behave responsibly toward fellow participants and staff.

Failure to comply may result in removal from the activity without refund.

10. Code of Conduct

Participants shall not:

- Consume illegal substances.
- Engage in violence, harassment, bullying, or abusive behavior.
- Damage property belonging to campsites, hotels, transport providers, or other participants.
- Engage in conduct that endangers themselves or others.

Gemini Adventure Camp reserves the right to remove participants violating these rules.

11. Transportation

- Transportation schedules are subject to traffic, weather, road conditions, and operational factors.
 - The Company shall not be liable for delays caused by circumstances beyond its reasonable control.
 - Participants must report at designated departure points on time.
